### **New Applications**

A).Bottom House Barn Buckhold Pangbourne Reading RG8 8QL

## 17/02009/HOUSE.

Proposal: Full glazed, structural glass storm porch and detached double car port with store room above.

No Objections plus condition as follows:

'it shall be used solely for purposes ancillary to the use of the existing dwelling house. No trade, or business or commercial enterprise of any kind whatsoever shall be carried on, in or from the outbuilding, nor shall it be used for additional bedroom accommodation or any form of human habitation'.

B) Bridle Lodge Back Lane Bradfield RG7 6DS 17/02110/HOUSE

Proposal: Partial demolition of an existing lean-to structure and a conservatory to construct a replacement two story extension. Insertion of a new dormer window and alterations to the existing dormers. Insertion of one new skylight. Minor alterations to windows on south façade and upgrade to all other existing windows.

OBJECT - mass bulk of the new application. The history of the current building, when developed from the original bungalow, was very concerned with the bulk nature of the proposal, in such close proximity to the highway. The introduction of the hipped roof and other reductions in the development size, resulted in the current dwelling house. This application undoes all of that. The Parish Council are at odds with the light nature of timber cladding.

- C) The Old Bakery 17/02404/HOUSE removal of rear lean-to roof and dormer window. New flat roof to existing ground floor rear extension. New gable wall and roof to existing first floor bedroom. No Objections.
