19/00646/FUL Bradfield College, Bradfield Internal alterations to main College dining hall and associated dishwasher, servery and corridors. Works comprise: Removal of: Asbestos; suspended ceilings; of existing convector heaters within the dining hall; partition walls within the dishwasher area; crockery store; electrical cupboard and dishwasher equipment; doors within corridor adjoining dishwasher area; of doors and infilled doorways within servery and infilling of existing entrance to dining hall from servery. Installation of : new dishwasher and associated draining including grease trap; new servery furniture, suspended and floating ceilings and doors; fire shutter and extension to kitchen area; new electrical cupboard, new built-in cupboards and new partition walls, including dark wood half height panelling, new convertor heaters, new and refurbished lighting and acoustic wall panels within dining hall and repositioning of approved glass partition doors between Snake door and corridor. Installation of new air handling units and strengthening of flat roof. Introduction of fire lining on ceiling within basement,
